Sending funds to KBRFX

- A margin deposit will be required by KBRFX on all forward contracts and the balance due on value date on maturity. You will be advised of the margin required at the time of the trade.
- KBRFX can only accept payment from bank accounts in the client's own name and not from a third party, unless prior arrangements have been agreed.
- KBRFX offer one free transfer abroad, however some banks may deduct a charge on receipts of funds. KBRFX adopts anti-money laundering legislation and guidelines as a policy.
